

**RESOLUTION NO. 2018-144**

**A RESOLUTION ESTABLISHING ELECTION PRECINCTS AND POLLING  
PLACES**

**FOR THE CITY OF COTTAGE GROVE, MINNESOTA;  
REPEALING RESOLUTION NO. 12-019**

WHEREAS, Minnesota Election Laws allow for the changing of precinct boundaries and designate new polling places, and

WHEREAS, the City Clerk has determined it is necessary to rearrange current precinct boundaries; now

THEREFORE, BE IT RESOLVED, by the City Council of the City of Cottage Grove, County of Washington, State of Minnesota, that Resolution No. 12-019 adopted on March 21, 2012, is hereby repealed, and that new election precincts and polling places shall be as following:

Precinct #1 - Cottage Grove Elementary School, 7447 65<sup>th</sup> Street South

Beginning at the intersection of T.H. 61 and the westerly Cottage Grove corporate border boundary; thence north to the intersection with the Woodbury corporate border; thence east along said border to Jamaica Avenue, thence south on Jamaica Avenue to 70<sup>th</sup> Street; thence west along 70<sup>th</sup> Street to the point of beginning.

Precinct #2 - Park Senior High School Field House, 8040 80<sup>th</sup> Street South

Beginning at the intersection of T.H. 61; thence north along the westerly Cottage Grove corporate border; thence east along 70<sup>th</sup> Street to Jamaica Avenue; thence south on Jamaica Avenue to 80<sup>th</sup> Street; thence west on 80<sup>th</sup> Street to T.H. 61 Thence Northwest along T.H. 61 to the point of beginning.

Precinct #3 - Cottage Grove Middle School, 9775 Indian Blvd South

Beginning at the intersection of Military Road, and the Woodbury corporate border with Cottage Grove; thence east on said border to Manning Avenue; thence south to the intersection of Manning Ave and T.H. 61; thence northwest along T.H. 61 to Keats Avenue; thence north on Keats Avenue to 80<sup>th</sup> Street; thence west along 80<sup>th</sup> Street to Jamaica Avenue; thence north on Jamaica Avenue to the point of beginning.

Precinct #4 - District 833 Service Center, 7362 East Point Douglas Road South

Beginning at the intersection of T.H. 61 and 80<sup>th</sup> Street; thence east on 80<sup>th</sup> Street to Jamaica Avenue; thence south on Jamaica Avenue to Hillside Trail; thence west on Hillside Trail to Ivywood Avenue; thence south on Ivywood Avenue to the juncture with 88<sup>th</sup> Street; thence continuing west along 88<sup>th</sup> Street to Ironwood Avenue; thence northwest along Ironwood Avenue to Inwood Avenue, thence north along Inwood Avenue to 85<sup>th</sup> Street; thence west along 85<sup>th</sup> street to Imperial Avenue; thence south on Imperial Avenue to Iden Avenue; thence southwest on Iden Avenue to Harkness Road; thence northwest along Harkness Road to Ideal Avenue; thence south along Ideal avenue to Highway 61; thence northwest along Highway 61 to the point of beginning.

Precinct #5- Washington County South Service Center, 13000 Ravine Parkway South

Beginning at the intersection of Jamaica Avenue and 80<sup>th</sup> Street; thence east along 80<sup>th</sup> Street to Keats Avenue; thence south on Keats Avenue to 90<sup>th</sup> Street; thence west on 90<sup>th</sup> Street to Jamaica Avenue; thence north on Jamaica Avenue to the point of beginning.

Precinct #6 - District 833 Program Center, 8400 East Point Douglas Road South

Beginning at the intersection of Jamaica Avenue and Hillside Trail; thence west on Hillside Trail to Ivywood Avenue; thence south on Ivywood Avenue to the juncture with 88<sup>th</sup> Street; thence continuing west along 88<sup>th</sup> Street to Ironwood Avenue; thence northwest along Ironwood Avenue to Inwood Avenue; thence north along Inwood Avenue to 85<sup>th</sup> Street; thence west along 85<sup>th</sup> Street to Imperial Avenue; thence south on Imperial Avenue to Iden Avenue; thence southwest on Iden Avenue to Harkness Road; thence northwest along Harkness Road to Ideal Avenue; thence south along Ideal Avenue to T.H. 61; thence southeast along T.H. 61 to Keats Avenue; thence north on Keats Avenue to 90<sup>th</sup> Street, thence west on 90<sup>th</sup> Street to Jamaica Avenue; thence north on Jamaica Avenue to the point of beginning.

Precinct #7 - National Guard Armory, 8180 Belden Boulevard South

Beginning at the intersection of T.H. 61 and the corporate boundary between Cottage Grove and St Paul Park; thence south along said border to the intersection with the corporate boundary between Cottage Grove and Grey Cloud Township; thence continuing along the southerly and easterly Cottage Grove corporate border until it intersects with T.H. 61 in section 36T27R21; thence northwest along T.H. 61 to the point of beginning.


FURTHER, that the afore-described polling places and election precincts shall be effective on the date of the 2019 Election, and


FURTHER, the City Clerk or the County Auditor shall notify each registered voter of the change in election precinct boundaries and polling place at least 14 days prior to the 2019 Election, and

FURTHER, a posted notification of all precinct changes shall be posted in the office of the City Clerk for at least 60 days prior to the effective date of the change.

FURTHER, the City Clerk shall prepare maps showing the correct boundaries of each election precinct and shall forward maps to the Secretary of State and County Auditor. One map shall be available for public inspection in the Office of the City Clerk.
